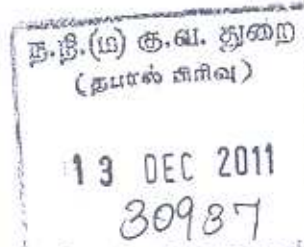

(ii) Post graduate degree/diploma in Town /City/Urban/Regional Planning from a recognised University or equivalent.  
(iii) 15 years professional experience in Town Planning.
