Sub: ESTABLISHMENT - Absorption of Tamilnadu Steel Limited employees in Municipalities-Recovery of V.R.S. amount from the employees of Tamil Nadu Steel Limited who have got employment in Municipalities- Regarding.

In the G.Os first and 2nd cited, Government have ordered that Tamil Nadu Steel Ltd., employees who have opted for VRS sanctioned in G.O.222, Industries dt.16.6.98 have been relieved consequently eligible to be absorbed on other public sector undertakings, Municipalities and Corporations etc. However, on absorption in other public sector undertakings, the VRS compensation given to them would be collected back in easy monthly instalments. The public sector undertakings/municipalities who absorb these employees will refund the amount so collected to the Government.

Therefore, the Municipal Commissioners are hereby instructed to recover the VRS compensation amount from the employees of Tamilnadu Steel Ltd., Arakkonam as indicated in the Annexure and credited into the following Head of Account with information to Industries Department.
