The Government in their above reference have decided that the construction of Cinema Theotre may be permitted in residential areas under the Town Planning Scheme prepared under the Madras Town Planning Act, 1920, subject to the conditions mentioned in G.O.No.1659, Home, dated 3-6-60.

The Government have also requested the Commissioner, Corporation of Madras and the Executive Authorities of Municipalities and Panchayats to make necessary provisions in draft Town Planning Schemes and also to send necessary amendments to the provisions of sanctioned schemes.

In the draft scheme provisions, the existing clause 14(1) reads as follows:-

14(1). "Save as otherwise provided in the scheme every part of the area shall be entirely utilised for residential purpose only, provided that residential hotels, clubs and buildings for public worship or instruction (other than a reformatory or industrual school or for mentally defective or epileptic person), or buildings intended as places of social intercourse, entertainment or recreation or as hospitals or dispendaries or for any other similar purposes, may be permitted by the Responsible Authority with the previous approval of the Director".

In order to reserve suitable areas for construction of Cinema Theatres in the residential zones in the scheme, the clause 14(1) may be revised and ingorporated in the draft schemes as indicated below:-

14(1). "Save as otherwise provided in the scheme every part of the area shall be entirely utilised for residential purpose only provided that residential hotels, clubs and buildings for public worship or instruction (other than a reformatory or industrial school or for mentally defective or epileptic person) or buildings intended as places of social intercourse entertainment or recreation or as hospitals or dispensaries or for Cinema Theatres of for any other similar purposes, may be permitted by the Responsible Authority with the previous approval of the Director".

In respect of sanctioned Town Planning Schemes, the Commissioner Corporation of Madras, the Executive Authorities of Municipalities and Panchayats are also requested to send necessary variations to the concerned, provisions of the sanctioned Town Planning Schemes to the Government, through the Director of Town Planning.
