6.Instructions issued by Secretary to Government, MAWS

Department during the review of TNUDP-III scheme.

As you are aware, the Hon'ble Minister for Rural Development and Local Administration has inaugurated the commencement of work on the Under Ground Sewerage Schemes for Namakkal and Sivagangai Municipalities on 10th and 23rd of December 2006 respectively. Both the schemes are to be implemented under the TNUDP-III. The financial tie-up for these schemes is as indicated below:-

The World Bank, after the completion of its second implementation support Mission (October 3rd to 7th of 2006) of the TNUDP-III, in its letter dated 29.11.2006 (copy enclosed) to the Chief Secretary to Government, has emphasized the following issues:-

- 1. Contractual Arrangements are to be put in place between Urban Local Bodies(ULBs) and state implement agencies (like TWAD, CMWSSB, etc.) for sub-project implementation. A format has been finalised during this mission.
- 2. Lack of contractual obligations to ULBs in project preparation and supervision by Metro Water and TWAD Board
 Action: It was agreed that all project preparation and supervision works under taken by state agencies ie. TWAD Board and Metro Water will be under a Memorandum of Understanding (MOU) clearly spelling out the obligations of contracting parties. A draft outline for MOU was agreed upon during the mission (Annexure 7) and same will be entered into by TWAD / CMWSSB with the ULB by December 2006 for all on-going subprojects.

In this connection, based on the Aide-Memoire of the World Bank, a draft agreement has been prepared in consultation with the Tamil Nadu Urban Infrastructure and Financial Services Limited and a template has been forwarded on 18.10.2006 in my D.O.letter No. 57104/06 UGSS dated 18.10.2006 to the Secretary to Government, Municipal Administration and Water Supply Department. A copy of this format of Contract for the Implementing Agencies Services is herewith enclosed for your reference. The intention is to ensure a type of agreement which would be binding on both the borrower and the Implementing Agencies so as to ensure quality, adherence to payment schedules and greater over all responsibility.

Instructions have been issued to both the concerned Municipalities to ensure compliance of these directives.

You are also aware that Water Supply Improvement Schemes to the following Municipalities have been cleared under the Urban Infrastructure Development Scheme for Small and Medium Towns Programme of the Jawaharlal Nehru National Urban Renewal Mission.

In this connection, I would like to draw your attention to G.O. No. 51, MAWS Dept dated 9.3.2001 (copy enclosed) in which Government have issued guidelines in respect of Water Supply Schemes. This includes the format for the Memorandum of Understanding (MOU) to be signed by the Commissioners of the respective Municipalities and the concerned Executive Engineers of TWAD Board in respect of schemes to be implemented by the Board. Further, the Government Order also elaborately delineates the connected modalities of Handing Over / Taking Over of schemes on completion.

Your Predecessor Thiru A.M. Kasiviswanathan, I.A.S., in his letter dated 25.3.2001 (Copy enclosed) to all the concerned officers has communicated the contents of the Government Order and instructed the Chief Engineers / Superintending Engineers / Executive Engineers to comply with these instructions. All the nine Municipalities in which these schemes are to be taken up have been instructed to comply with the said Government Order.

This subject has also come up for discussion during the meeting with the Secretary to Government, Municipal Administration and Water Supply Department on 9.12.2006. It was agreed that the Agreement in the form of Memorandum of Understanding should be signed by the implementing Agencies and the Urban Local Bodies.

Under these circumstances, I would request you to give suitable instructions to your field officers to scrupulously follow the guidelines mentioned above.
