NOTIFICATIONS BY THE ELECTION COMMISSION OF INDIA.

DISQUALIFICATION OF CERTAIN CANDIDATES CONTESTED FROM 60. THIRUNAVALUR, 64. PANRUTI, 65. KURINJIPADI, 66. BHUVANAGIRI, 67. KATTUMANNARKOIL (SC), 69. VRIDHACHALAM, 70. MANGALORE (SC), 74. HOSUR, 114. PONGALUR, 160. PERAMBALUR (SC), 162. ARIYALUR, 164. JAYANKONDAM, 173. NANNILAM (SC) AND 177. THIRUTHURAIPOONDI (SC) ASSEMBLY CONSTITUENCIES IN THE GENERAL ELECTIONS TO TAMIL NADU LEGISLATIVE ASSEMBLY, HELD IN MAY, 2006 FOR FAILURE TO LODGE ACCOUNTS OF ELECTION EXPENSES UNDER SECTION 10A OF THE REPRESENTATION OF THE PEOPLE ACT, 1951.

The following order of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110 001, dated 9th February, 2009 [20 Magha, 1930 (Saka)] is published:—

No. 76/TNLA/2007.—Whereas, the Election Commission is satisfied that each of the contesting candidates specified in column (3) of the Table below at the Election to the Tamil Nadu Legislative Assembly, 2006 held from the Constituency specified in the column (2) against his/her name has failed to lodge an account of his/her election expenses as mentioned in column (4) of the said Table, as required by the Representation of the People Act, 1951 and the Rules made thereunder;

And, whereas, the said candidates has either not furnished any reason or explanation for the said failures even after due notice to each of them and the Election Commission is satisfied that they have no good reason or justification for the said failure;

Now, therefore, in pursuance of Section 10A of the said Act, the Election Commission hereby declares the persons specified in column (3) of the Table below to the disqualified for being chosen as and for being, a member of either House of the Parliament or Legislative Assembly or Legislative Council of a State for a period of 3 years from the date of this Order.
