Extension of period of taken over of Chikkiah Naicker College, Erode.

No. II(2)/HE/57/2009.

[Aided College—Chikkiah Naicker College, Erode—To extend the take over of the college by the Government under Section 30 (3) of the Tamil Nadu Private Colleges (Regulation) Act, 1976—for a further period of one year with effect from 19th December 2008—Orders—Issued.]

Order: No. 8, Higher Education (D2), 7th January 2009, Margazhi 23, Thiruvalluvar Aandu-2039.

In the Government order first read above orders were issued to take over the management of Chikkiah Naicker College, Erode under section 30(1) of the Tamil Nadu Private Colleges (Regulation) Act, 1976 for a period of two years with effect from 19th December 2002 and appointed the Regional Joint Director of Collegiate Education, Coimbatore Region, as caretaker to run the management of the said college.

- 2. In the Government order second read above, the Government have ordered for extension to take over the management of the Chikkiah Naikker College, Erode, for a period of one year with effect from 19th December 2004 and also to extend the term of the Special Officer appointed as per the G.O. first read above to run the management of the said College.
- 3. In the G.Os. 3rd to 5th read above, the Government sanctioned the further extension of the take over and continuance of term of the caretake year by year upto 18th December 2008. The present sanction expires on 18th December 2008.
- 4. In the letter sixth read above, the Director of Collegiate Education has stated that the term of the period of the Special Officer expired on 18th December 2008. There is no proper Educational Agency to run the management of Chikkiah Naicker College. the W.P.No. 11019/2002 filed by Thiru R. Aswath, Secretary, Chikkiah Naicker Educational Board, Erode and W.P.No. 4399/2001 filed by Thiru, T.A. Shanmugasundaram, Secretary, Mahajana Educational Board, Erode to hand over the management of the said college was dismissed by the High Court. Against these orders the petitioners filed Writ Appeals in W.A. Nos. 1670/2005 and 1671/2005 and they are still pending before the High Court. The Administration of this College cannot

be transferred to any other agency at present. There is no Possibility to constitute an Educational Board. The Director of Collegiate Education has, therefore, requested to extend the period of take over of the management and term of the Special Officer for a further period of one year with effect from 19th December 2008 as per proviso to section 30 (3) of the Tamil Nadu Private Colleges (Regulation) Act, 1976.

5. The Government, after careful consideration, have decided that it is expedient in the interests of students' Education to extend the take over the Management of Chikkiah Naicker College, Erode. Now, therefore, in exercise of the powers conferred under the proviso to sub-section (3) of section 30 of the Tamil Nadu Private Colleges (Regulation) Act, 1976 (President's Act 19 of 1976), the Governor of Tamil Nadu hereby extends the take over the management of the Chikkiah Naicker College, Erode for a further period of one year with effect from 19th December 2008 to 18th December 2009 and appoints the Regional Joint Director of Collegiate Education, Coimbatore as Care Taker to run the management of the said College.
