It is notified for information of the public that in connection with introduction of 25kv ac electric traction on and from the dates mentioned against the following sections of Southern Railway, height gauges have been erected at all the level crossings with clear height of 4.67m, above road level with a view to prevent loads of excessive height from coming into contact or dangerous proximity to "LIVE" Traction Wires:—

Public are hereby, notified to observe the height specified above for the purpose of loading Vehicles and to see that the loads carried in road vehicles do not infringe the height gauges under any circumstances.

The Dangers of a load of excessive height are as follows:-

- (i) Danger to the height gauge and consequent obstruction to the Road as well as the Railway line.
- (ii) Danger to the materials or equipments carried or the vehicle itself.
- (iii) Danger of fire and risk of life due to contact with or dangerous proximity to the conductor.

PUBLIC DEPARTMENT (S.C.)

Declaration of the premises of Indian Oil Corporation Limited, Repeater-cum-Cathodic Protection Station at Gopalapuram, Attur Taluk, Salem District as "Prohibited Place" under the Official Secrets Act.

[G.O. No. S.S. II/581-8/2008, Public (S.C.), 21st February 2009.]

No. II(1)/PUSC/2/2009.—Whereas, in the opinion of the Government of Tamil Nadu, it is necessary to declare the premises of Indian Oil Corporation Limited, Repeater-*cum*-Cathodic Protection Station at Gopalapuram, Attur Taluk, Salem District, specified in the Schedule below, to be a "Prohibited Place" under sub-clause (*d*) of Clause (8) of Section 2 of the Official Secrets Act, 1923 (Central Act XIX of 1923), on the ground that information with respect thereto, or the destruction or obstruction thereof, or interference therewith, would be useful to an enemy:

And, Whereas, in pursuance of clause (1) of Article 258 of the Constitution of India, the Government of India, Ministry of Home Affairs, have, in their Notification No. S.O. 1285, dated the 4th May 1963, published in the *Gazette of India*, dated the 11th May 1963, entrusted to the Government of Tamil Nadu, the functions of the Central Government in relation to any matter specified in sub-clauses (c) and (d) of clause (8) of Section 2 of the Official Secrets Act, 1923 (Central Act XIX of 1923);

Now, Therefore, in exercise of the powers conferred by sub-clause (*d*) of clause (8) of Section 2 of the Official Secrets Act, 1923 (Central Act XIX of 1923), the Governor of Tamil Nadu hereby declares, with effect on and from the date of publication of this Notification in the *Tamil Nadu Government Gazette*, the premises of Indian Oil Corporation Limited, Repeater-*cum*-Cathodic Protection Station at Gopalapuram, Attur Taluk, Salem District specified in the Schedule below to be a "Prohibited Place" for the purposes of the said Act.
