No. SRO A-45/2008.—The following Notification of Government of India, Ministry of Shipping, Road Transport and Highways (Department of Road Transport and Highways) New Delhi, the 15th July 2008 is republished:—

G.S.R. 521(E).—Whereas the draft of the Central Motor Vehicles (Amendment) Rules was published *vide* number G.S.R. 71(E), dated the 5th February, 2008, as required by sub-section (1) of Section 212 of the Motor Vehicles Act, 1988 (59 of 1988), inviting objections and suggestions from all persons likely to be affected thereby before expiry of the period of sixty days from the date on which copies of the Gazette of India in which the said notification was published, were made available to the public;

And, whereas, copies of the said Gazette notification were made available to the public on the 11th February, 2008;

And, whereas, the objections and suggestions received from the public on the said draft rules have been duly considered by the Central Government;

Now, therefore, in exercise of the powers conferred by Section 27 of the said Motor Vehicles Act, the Central Government hereby makes the following rules further to amend the Central Motor Vehicles Rules, 1989, namely:—

- 1. (1) These rules may be called the Central Motor Vehicles (Amendment) Rules, 2008.
 - (2) They shall come into force on the date of their final publication in the Official Gazette.
- 2. In the Central Motor Vehicles Rules, 1989 (hereinafter referred as the said rules), for Form 6, the following form shall be substituted, namely:—
