#### Amendment to the Indian Stamp Rules, 1925.

[G.O. Ms. No. 106, Commercial Taxes and Registration (J1), 6th November 2008, Aippasi, 21, Thiruvalluvar Aandu-2039.]

No. SRO A-46/2008.—In exercise of the powers conferred by Section 75 of the Indian Stamp Act, 1899 (Central Act II of 1899), the Governor of Tamil Nadu hereby makes the following amendment to the Indian Stamp Rules, 1925:—

In the said Rules, in rule 3, in sub-rule (i) after expression "franking machines", the expression " or through electronically generated stamps" shall be inserted.

## Amendments to Tamil Nadu Cinemas (Regulation) Rules, 1957.

[G.O. Ms. No. 1217, Home (Cinema), 23rd September 2008.]

No. SRO A-47/2008.—In exercise of the powers conferred by Section 10 of the Tamil Nadu Cinemas (Regulation) Act, 1955 (Tamil Nadu Act IX of 1955), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Cinemas (Regulation) Rules, 1957.

#### **AMENDMENTS**

In the said Rules,-

- (1) In rule 11, for sub-rule (1), the following sub-rule shall be substituted, namely:—
- "(i) The enclosure shall be in charge of Cinema Operator holding a competency certificate in Form 'H' issued by the Board of Examiners of the Cinema Operators, Chennai. The Cinema Operator shall be present in the enclosure during the whole period of operation of the machine. There shall be two cinema operators having competency certificate in each of the permanent and semi-permanent theatres exhibiting a minimum of three shows per day and in the case of a permanent or semi-permanent theatres which exhibits more than four shows per day, the number of cinema operators shall be three";
- (2) In FORM C in condition 14-A, in clause (iii), for the expression "licensed operators" the expression "cinema operators holding competency certificate" shall be substituted;
  - (3) In FORM D on the Reverse,
- (a) for the expression "Licence Number", the expression "cinema operator competency certificate number" shall be substituted;
- (b) for the expression "Period of validity of licence", the expression "Period of validity of cinema operator competency certificate" shall be substituted;
- (c) for the expression "licensed operator", the expression "cinema operator holding competency certificate", shall be substituted;
  - (4) FORM G shall be omitted;
  - (5) for FORM H, the following FORM shall be substituted, namely:-

# CONDITIONS

- 1. This Certificate should be produced on demand by the inspecting officer.
- 2. This Certificate holder shall inform in writing to the concerned Electrical Inspector, whenever he proceeds on leave, resigns or accepts new appointment.
- 3. (a) The Board of examiners of the Cinema Operators issuing the certificate may on receipt of application and the fee prescribed below, renew the said Certificate for a period of five years at a time. The certificate shall be renewed at the interval of five years at a time.
- (b) An application for renewal of the said Certificate shall be submitted to the said Board before three months from the date of expiry of its period of validity along with the postal order for Rs. 50/- (Rupees fifty only) drawn in favour of the Secretary, Board of Examiners for Cinema Operators payable at Chennai towards the fee for such renewal:

Provided that applications received after the expiry of the Competency certificate, fee of Rs. 10/-(Rupees ten only) for each month in addition to the actual renewal fee, shall be paid.

- 4. The following documents shall be accompanied with the renewal applications:—
  - (i) Two copies of photographs of applicant in 5 cm x 7.5 cm size taken within a year of application;
  - (ii) Two specimen signatures with thumb impression;
  - (iii) Medical certificate obtained from a Registered Medical Practitioner;
  - (iv) Present address (with details of pertaining to the present employment);
  - (v) Original Cinema Operator Competency Certificate",
- 6. Appendix II shall be omitted.

#### LABOUR AND EMPLOYMENT DEPARTMENT

#### Amendment to Tamil Nadu Payment of Wages Rules, 1937.

No. SRO A-48/2008.—In exercise of the powers conferred by sub-section (2) of Section 26 of the Payment of Wages Act, 1936 (Central Act IV of 1936), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Payment of Wages Rules, 1937, the draft of the same having been previously published as required under sub-section (5) of Section 26 of the said Act.

#### **A**MENDMENT

In the said Rules, in rule 23, for the expression "which may extend to two hundred rupees", the expression "which shall not be less than seven hundred and fifty rupees, but which may extend to one thousand and five hundred rupees" shall be substituted.
