Now therefore in exercise of the powers conferred by sub-section 2 of Section 4 of the said Act, the Governor of Tamil Nadu hereby authorises the sub Collector, Cheranmahadevi and his Staff and workmen to exercise the powers conferred by the said sub-section.

Under sub section 4 of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that in view of the urgency of the case under Clause (C) of Section 3 of the said Act, the provisions of Section 5A of the said Act, shall not apply to this case.
