#### [G.O. Rt. No. 91, Labour and Employment (D2), 18th February 2010.]

No. II(2)/LE/154//2010.—Whereas, the Governor of Tamil Nadu is satisfied that public interest requires that "Industrial Units established in the Special Economic Zones" should be declared to be a public utility service for the purposes of the Industrial Disputes Act, 1947 (Central Act XIV of 1947).
