Amendment to the Tamil Nadu State Legal Services Authority Rules, 1997

Amendment to the Tamil Nadu Factories Rules, 1950

No. SRO A-2/2010.—In exercise of the powers conferred by Section 112 of the Factories Act, 1948 (Central Act LXIII of 1948), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Factories Rules, 1950, the draft of the same having been previously published as required by Section 115 of the said act:—

In the said Rules, in rule 3, to sub-rule (2), the following proviso shall be added, namely:—

"Provided that where an application for such permission has been made in the common application form for single window clearance approved in G.O. Ms. No. 203, Industries (MIB-I) Department, dated 24th December 2001 then making of an application in Form No. 1 is not necessary."

No. SRO A-3/2010.—In exercise of the powers conferred by Section 9 of the Tamil Nadu Payment of Salaries Act, 1951 (Tamil Nadu Act XX of 1951), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Ministers Travelling Allowance Rules, 1951.

2. The amendment hereby made shall be deemed to have come into force on and from the 29th May, 2009.

AMENDMENT

In the said Rules, in rule 2, in sub-rule (1), for the expression "Chief Minister", occurring in seven places the expression "Chief Minister or the Deputy Chief Minister" shall be substituted.
