#### Amendments to the Special Rules for the Tamil Nadu Medical Subordinate Service.

[G.O. Ms. No. 97, Health and Family Walfare (C2), 5th April 2010, Panguni 22, Thiruvalluvar Aandu-2041.]

No. SRO B-33/2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu, hereby makes the following amendments to the Special Rules for the Tamil Nadu Medical Subordinate Service (Section 21 in Volume III of the Tamil Nadu Services Manual, 1970).

- 2. (1) The amendment (1) (i) hereby made shall be deemed to have come into force on the 14th December 1982.
- (2) The amendments (1) (ii) and (3) (i) hereby made shall be deemed to have come in to force on the 13th June 2000.
  - (3) The amendments 2 and 3 (ii) hereby made shall come in to force on and from the date of issue of this order.

#### **AMENDMENTS**

In the said Special Rules, in Part-II, under the heading "Branch IV-General",-

- (1) (i) for the category "5. Laundry Mechanic Chargeman", wherever it occurs the category "5. Junior Engineer (Mechanical)" shall be substituted;
  - (ii) for the category "5. Junior Engineer (Mechanical)", as so substituted, wherever it occurs, the category "5. Junior Engineer (Steam Laundry)" shall be substituted;
- (2) in rule 2, in sub-rule (a), under 'Class-IV', for the entries in column (2) against the category "5. Junior Engineer (Steam Laundry)", as so substituted, in column (1) thereof, the following entries shall be substituted, namely:—
  - "(i) by promotion from any other category; or
  - (ii) by recruitment by transfer from any other service, if no candidate is available by the above method; or
    - (iii) by direct recruitment, if no candidate is available by the above two methods.";
- (3) in Annexure-II, under 'Class-IV',-
  - (i) for the entries in column (2) against the category—"5. Junior Engineer (Steam Laundry)", as so substituted, in column (*I*) thereof, the following entries shall be substituted, namely:—
    - "(1) Must possess a diploma in Mechanical Engineering or Electrical Engineering; or";
    - (ii) after the aforesaid entry, as so substituted, the following entry shall be added, namely:-
  - "(2) Must possess a diploma in Refrigeration and Air conditioning awarded by the Director of Technical Education".

No. SRO B-35/2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules.

The rules hereby made shall be deemed to have come into force on the 9th day of June 2008.

# Rules

The Special rules applicable to the holders of the post of Private Secretary in category 4 in Class XII of the Tamil Nadu General Service shall apply to the holders of the temporary post of Principal Private Secretary, subject to the modifications specified in the following rules:—

- 1. Constitution.—The post shall constitute a separate category in the said Class of the said Service.
- 2. Appointment.—(a) Appointment to the post of Principal Private Secretary in the Departments of Secretariat other than Finance and Planning, Development and Special Initiatives Departments shall be made by promotion from among the holders of the post of Senior Private Secretaries in the Departments of Secretariat under one unit other than Finance and Planning, Development and Special Initiatives Departments.
- (b) Appointment to the category of Principal Private Secretary under one unit shall be made by the Secretary to Government, Personnel and Administrative Reforms Department from among the eligible persons in the cadre of Senior Private Secretary.
- (c) Selection of persons for appointment to the post shall be made on grounds of merit and ability, seniority being considered only where merit and ability are approximately equal.
- 3. Unit of Appointment.—All Departments of Secretariat except Finance and Planning, Development and Special Initiatives Departments shall be treated as a single unit for this purpose.
- **4.** Pay.—There shall be paid to the holders of the post, a monthly pay calculated in the scale of pay of Rs.15,600-39,100+Rs.7,600 (Pay Band 3).
