#### HOME DEPARTMENT

#### Amendment to Special Rules for Tamil Nadu Special Police Subordinate Service, 1978.

[G.O. Ms. No. 408, Home (Pol.IX), 27th April 2010.]

No. SRO B-41/2010.—In exercise of the powers conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and Sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act III of 1888) read with the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Special Police Subordinate Service Rules, 1978 (Section 44 in Volume III of the Tamil Nadu Services Manual, 1986).

2. The amendment hereby made shall be deemed to have come into force with effect on and from the 20th November 2009.

#### **A**MENDMENT

In the said Rules, in rule 16, for sub-rule (1), the following sub-rule shall be substituted, namely:—

"(1) Every person appointed to the posts of Inspector, Havildar and Naik, appointed otherwise than by promotion shall, within the prescribed period of his probation, undergo training in Tamil Nadu Special Police work for a period of not less than ten months to the satisfaction of the Commandant. The aforesaid period of training in respect of the post of Constables shall be 22 weeks followed by one month practical training."

#### Amendments to Ad hoc Rules relating to the post of Carpenter in Government Museum, Chennai.

[G.O. Ms. No. 77, Tourism and Culture (MA-1), 29th April 2010, Chithirai 16, Thiruvalluvar Andu-2041.]

No. SRO B-42/2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Education and Public Health Department Notification SRO No. A-246 of 1961, published at page 325 of Part V of the *Fort St. George Gazette*, dated the 15th March 1961.

2. The amendments hereby made shall come into force on 29th April 2010.

#### **A**MENDMENTS

In the said Rules, in rule 5,-

- (1) for clause (ii), the following clause shall be substituted, namely:-
- "(ii) In the case of Carpenter, must have passed the Secondary School Leaving Certificate Examination and must possess Industrial Training Institute Certificate in Carpentry Trade and experience for a period of not less than three years in carpentry work".
  - (3) "Note (1) and Note (2) shall be omitted."

#### Saving Clause:

Nothing contained in these rules should adversely affect the holders of the post on the date of issue of order.

### Amendments to Ad hoc Rules relating to the post of Cabinet Maker, Painter/Polisher in Government Museum, Chennai.

No. SRO B-43/2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu, hereby makes the following amendments to the rules published with the Tamil Development-Culture Department Notification SRO No. B. 295/89, at pages 205-206 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 30th August 1989.

2. The amendment hereby made shall have come into force on 29th April 2010.

#### **AMENDMENTS**

In the said Rules, in rule 5, in sub-rule (b), in the Table:-

- (1) for the entries in column (3) against the post "Cabinet Maker" in column (1) thereof, the following entries shall be substituted, namely:—
  - (a) Must have passed the Secondary School Leaving Certificate Examination;
  - (b) Must possess Industrial Training Institute Certificate in Carpentary work;
  - (c) Must possess three years experience in Cabinet Making works;
- (d) Must have passed the tests conducted by Curator, Design and Display Section of the Government Museum in preparing Cabinet and preparing show cases.
- (2) for the entries in column (3), against the post "Painter/Polisher", in column (1) thereof, the following entries shall be substituted, namely:—
  - (a) Must have passed the Secondary School Leaving Certificate Examination;
  - (b) Must possess Industrial Training Institute Certificate in Painting/Polishing;
  - (c) Must possess three years experience in Painting/Polishing works.

Nothing contained in these rules should adversely affect the holders of the post on the date of issue of order.

No. SRO B-44/2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu, hereby makes the following amendments to the rules published with the Education, Public Health Department Notification SRO No. A-120 of 1967, published at pages 119-120 of Part V of the *Fort St. George, Gazette,* dated the 15th February 1967.

2. The amendment hereby made shall come into force on 29th April 2010.
