Tamil Nadu Administrative Tribunal (Salaries and Allowances and Conditions of Service of Chairman, Vice-Chairman and Members) Amendment Rules, 2010.

No. SRO A-22/2010.—The following Notification issued by the Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training, Government of India, New Delhi, the 29th March, 2010 is republished:—

G.S.R. 225(E)—In exercise of the powers conferred by sub-section (1) read with clause (c) of sub-section (2) of Section 35 and Section 36-A of the Administrative Tribunal Act, 1985 (13 of 1985), the Central Government hereby makes the following rules further to amend the Tamil Nadu Administrative Tribunal (Salaries and Allowances and Conditions of Service of Chairman, Vice-Chiarman and Members) Rules, 1988, namely:—

1. (1) These rules may be called the Tamil Nadu Administrative Tribunal (Salaries and Allownaces and Conditions of Service of Chairman, Vice-Chairman and Members) Amendment Rules, 2010.

(2) They shall be applicable to the Chairman, Vice-Chairman and Members of the Tamil Nadu Administrative Tribunal appointed before the 19th February 2007.

(3) They shall be deemed to have come into force on the 29th June, 1988.

2. In Tamil Nadu Administrative Tribunal (Salaries and Allowances and Conditions of Service of Chairman, Vice-Chairman and Members) Rules, 1988, in rule (8), after sub-rule (2) the following sub-rule shall be inserted, namely:-

"(3) Gratuity:—The Members who have completed five years of service in the Tribunal shall be entitled for a retirement gratuity equal to one fourth of the emoluments for each completed period of six months of service subject to a maximum of sixteen and half time of the emoluments:

Provided that the total amount of gratuity payable to a Member under this clause and the amount of gratuity drawn by him in respect of services rendered in an organization or department before joining Tamil Nadu Administrative Tribunal shall not exceed the maximum amount of gratuity specified by the Central Government for officers of All India Service at the time of his retirement from Government service."
