### ANIMAL HUSBANDRY, DAIRYING AND FISHERIES DEPARTMENT

#### **Ad hoc Rules relating to Temporary post of Junior Assistant in the office of the Directorate of Audit for Milk Co-operatives, Chennai for Tamil Nadu Ministerial Service.**

*[G.O. Ms. No. 8, Animal Husbandry, Dairying and Fisheries (MP.II), 22nd January 2010.]*

No.SRO B-8/2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:—

2. The rules hereby made shall be deemed to have come into force on the 24th August 2007.

#### RULES

The General and the Special Rules applicable to the holders of the permanent post of Junior Assistant in the Tamil Nadu Ministerial Service shall apply to the holder of the temporary post of Junior Assistant in the Office of the Director of Audit for Milk Co-operatives, Chennai, subject to the modifications specified in the following rules:—

1. *Constitution.*—The post shall constitute a temporary addition to the said category in the said service.
2. *Appointment.*—Appointment to the post shall be made as follows—
  - (i) by direct recruitment; or
  - (ii) by recruitment by transfer.
3. *Appointing authority.*—The appointing authority for the post shall be the Director of Audit for Milk Co-operatives.

### HEALTH AND FAMILY WELFARE DEPARTMENT

#### **Ad hoc Rules relating to Temporary post of Associate Professor in Hand Surgery for Tamil Nadu Medical Service.**

*[G.O. Ms. No. 15, Health and Family Welfare (A1), 25th January 2010, Thai 12, Thiruvalluvar Aandu-2041.]*

No. SRO B-9/2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:—

2. The rules hereby made shall come into force on the 25th January 2010.

#### RULES

The General and the Special Rules applicable to the holders of the permanent post of Associate Professor in Class I, in Branch-I Medical of the Tamil Nadu Medical Service shall apply to the holder of the temporary post of Associate Professor in Hand Surgery, subject to the modifications specified in the following rules:—

2. *Constitution.*—The post shall constitute a distinct category in the said class of the said Branch of the said Service.
3. *Appointment.*—Appointment to the post shall be made as follows:—
  - (i) by transfer from the category of Associate Professor in Class I, Branch-I, Medical of the said Service; or
  - (ii) by promotion from the category of Assistant Professor in the Government Medical Colleges.

4. *Qualification.*—No person shall be eligible for appointment to the post unless he possesses the following qualifications, namely.—

- (i) Must Possess MS (Orthopaedics);
- (ii) Must possess teaching experience for a period of not less than five years as Assistant Professor in Orthopaedic Surgery in a Medical College or teaching institution recognized by the Medical Council of India, New Delhi;
- (iii) Must have served for a period of not less than two years in the Department of Hand Surgery; and
- (iv) Must possess two years certificate course in Hand Surgery in a Government Medical College or in any other Institution recognized by the Medical Council of India, New Delhi.

5. *Pay.*—There shall be paid to the holder of the post a monthly pay calculated in the scale of Rs. 15600-39100 and Grade Pay of Rs. 7600.

RURAL DEVELOPMENT AND PANCHAYAT RAJ DEPARTMENT

**Amendments to the Special Rules for the Tamil Nadu Panchayat Development Subordinate Service**

*[G.O. Ms. No. 9, Rural Development and Panchayat Raj (E4), 25th January 2010.]*

SRO B-10/2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Amendments to the Special Rules for the Tamil Nadu Panchayat Development Subordinate Service (Section 47 in Volume III of the Tamil Nadu Services Manual 1970).

2. (a) The amendments hereby made except to the post of Deputy Block Development Officer (Audit) and Deputy Block Development Officer (National Rural Employment Guarantee Scheme) shall be deemed to have come into force on the 28th August 2008.

(b) The amendments hereby made with reference to the post of Deputy Block Development Officer (Audit) shall be deemed to have come into force on the 1st July 1997.

(c) The amendments hereby made with reference to the post of Deputy Block Development Officer (National Rural Employment Guarantee Scheme) shall be deemed to have come into force on the 15th October 2007.

AMENDMENTS

In the said Rules,—

(1) in rule 1, for the Category 2 and Category 3, the following Category shall be substituted, namely:—

- “Category 2. (a) Deputy Block Development Officer (Administration);  
(b) Deputy Block Development Officer (Schemes);  
(c) Deputy Block Development Officer (Noon Meal Programme);  
(d) Deputy Block Development Officer (Small Savings and Public Relations);  
(e) Deputy Block Development Officer (Panchayats);  
(f) Deputy Block Development Officer (Adi Dravidar Welfare);  
(g) Deputy Block Development Officer (Accounts);  
(h) Deputy Block Development Officer (Audit);  
(i) Deputy Block Development Officer (National Rural Employment Guarantee Schemes),

All the above posts are commonly herein after referred to as “Deputy Block Development Officer.”;

(2) in rules, in THE TABLE under sub-rule (a),

(a) the entries in item (b) in Column (2) against the entry "Block Development Officer" in Column (1) and the second proviso shall be deleted.

(b) for the entries "Deputy Block Development Officer (Administration), Deputy Block Development Officer (Executive) and Deputy Block Development Officer (Accounts)" in column (1) and the corresponding entries in column (2) thereof, the following entries in column (1) and column (2) shall respectively be substituted, namely:—

"Deputy Block Development Officer

By recruitment by transfer from among the holders of the following posts in the Tamil Nadu Ministerial Services, namely:—

(i) Rural Welfare Officer Grade-I; or

(ii) Accountant or Assistant in the Directorate of Rural Development and Panchayat Raj; or

(iii) Accountant or Assistant in the Panchayat Development branches of the Collectorate and Panchayat Union Office";

(c) the entries "Extension Officer (Panchayats); Extension Officer (Social Education and Public Relations); Extension Officer (Administration); and Extension Officer (Accounts) in column (1) and the corresponding entries in column (2) thereof, shall be omitted;

(3) in THE TABLE under rule 3, —

(a) in column (3), against the entry "Block Development Officer" in column (1) and the entry "By promotion and by recruitment by transfer" in column (2) thereof, after item (2) the following items shall be added, namely:—

(3) "Must have served as Deputy Block Development Officer (Panchayats) independently for a period of not less than one year:

Provided that the Deputy Block Development Officer in the Office of the Directorate of Rural Development and Panchayat Raj Department shall not be eligible for promotion as Block Development Officer, unless they possess one year work experience as independent Deputy Block Development Officer (Panchayats) in the District to which they are allotted.

(4) Must have completed an integrated training for Deputy Block Development Officer (Panchayats) for a period of 15 days and the training for Deputy Block Development Officers other than Deputy Block Development Officer (Panchayats) for a period of 15 days:

Provided that the training mentioned in item (4) above shall not be insisted for the Assistant in the Office of the Director of Rural Development and Panchayat Raj."

(b) for the entries, "Deputy Block Development Officer (Executive), Deputy Block Development Officer (Administration) and Deputy Block Development Officer (Accounts)" in column (1) and the corresponding entries in column (2) and column (3) thereof, the following entries in column (1), column (2) and column (3) shall respectively be substituted, namely:—

"Deputy Block Development Officer:— By recruitment by transfer

(1) Must possess the Minimum General Educational Qualification specified in schedule I to the General Rules for the Tamil Nadu State and Subordinate Services;

(2) Must have passed the Departmental Test for Officers of Panchayat Development Department and Panchayat Development Account Test conducted by the Tamil Nadu Public Service Commission; and

(3) Must have served as Rural Welfare Officer, Grade-I and Assistant or Accountant for a period of not less than one year in each post."

---

(c) the entries "Extension Officer (Panchayats), Extension Officer (Social Education and Public Relation), Extension Officer (Administration) and Extension Officer (Accounts)" in column (1) and the corresponding entries in columns (2) and (3) thereof shall be omitted;

(4) in rule 5, in sub-rule (a), for the expression "category 3" the expression "category 2" shall be substituted.

(5) in rule 6,—for the proviso, the following proviso shall be substituted, namely:—

"Provided that the Deputy Block Development Officer (Administration), Deputy Block Development Officer (Accounts) in the Directorate of Rural Development shall constitute the Chennai District Unit";

(6) rule 8, shall be omitted.
