5. The following entries shall be substituted after deleting the entries in column No. 2, in the row of the B7B7 road:---

"North South road connecting Eastern part of B4B4 East West road passing through deleted AA Road and connecting North of B8B8 road in S.F. No. 436/3 part and 437/6 part.

6. The entry in column No. 4 against with B7B7 road 212' shall be removed 300'-0" shall be substituted.
