NOTIFICATIONS BY GOVERNMENT

ACQUISITION OF LAND

[G.O. Ms. No. 74, Transport (I.1), 13th June 2011.]

No. II(2)/TRA/253(d)/2011.

Whereas, in exercise of the powers conferred by clause (1) of the Article 258 of the Constitution of India, the President of India, has, in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No. 4(i)/65, General-II, dated the 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent, the function of the Central Government under the Land Acquisition Act, 1894 (Central Act I of 1894), in relation to the acquisition of land for the purpose for the Union in this State;

And, whereas, the Land specified in the Schedule below are needed for a public purpose to wit for dumping the excavated cut soil due to the formation of Salem-Karur Broad Gauge Railway Line Project, notified to the effect is hereby given to all to whom it may concern in accordance with the provisions of sub-section (1) of Section 4 of the Land Acquisition Act, 1894 (Central Act I of 1894);

And, whereas, it has become necessary to acquire the immediate possession of the Land specified in the Schedule below, the Governor of Tamil Nadu hereby directs that the Land to be acquired under the provisions of sub-section (2) of Section 17 of the said Act;

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 4 of the said Act, the Governor of Tamil Nadu hereby authorise the Special Tahsildar (Land Acquisition), Unit-I, Salem-Karur Broad Gauge Railway Line Project, Namakkal and his Staff and Workmen to exercise the powers conferred by the said sub-section under clause (c) of Section 3 of the said Act, the Governor of Tamil Nadu hereby appoints the Special Tahsildar (Land Acquisition), Unit-I, Salem - Karur Broad Gauge Railway Line Project, Namakkal to perform the functions of the Collector under the said Act.

Under sub-section (4) of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that, in view of the urgency of the case, the provisions of Section 5-A of the Act shall not apply to this case.
