Whereas in exercise of the powers conferred by clause (1) of the Article 258 of the constitution of India, the President of India has, in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No.4 (1)/65, General-II, dated the 23rd April 1966 entrusted to the Government of Tamil Nadu with their consent, the functions of the Central Government under the Land Acquisition Act, 1894 (Central Act I of 1894) in relation to Acquisition of Land for the purpose for the Union in this State;

And, whereas, it has already been decided that the compensation shall be paid from the public revenues;

Now, therefore, in exercise of the powers conferred by Section 6 of the said Act, the Governor of Tamil Nadu hereby declares that the Land specified in the Schedule below of 55 Solasiramani Village, Paramathivelur Taluk, Namakkal District, be the same a little more or less are needed for public purpose, to wit, construction of Bhavani Kattalai Barrage III Hydro Electric Project by Tamil Nadu Electricity Board. A plan of the Lands is kept in the Office of Tahsildar, Paramathivelur Taluk, Namakkal District and may be inspected at any time during the office hours.
