DECLARATION

Under Section 6 of the Land Acquisition Act, 1894 (Central Act I of 1894) the Governor of Tamil Nadu hereby declares that the land specified in the Schedule below and measuring 0.99.0 hectare or 9900 sq.m. be the same a little more or less are needed for public purpose to wit, for the implementation of Chennai Metro Rail Project.
