Now, Therefore, in exercise of the powers conferred by sub-section (2) of Section 4 of the said Act, the Governor of Tamil Nadu hereby authorizes the Special Tahsildar (Land Acquisition), Inter-linking of River Project - Unit I, Ambasamudram Taluk at Cheranmahadevi and his staff and workmen to exercise the powers conferred by the said sub-section.
