##### ACQUISITION OF LANDS

Whereas, in exercise of the powers conferred by clause (1) of Article 258 of the Constitution of India, the President of India has, in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No. 4(1)/65, General-II, dated 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent, the functions of the Central Government under the Land Acquisition Act, 1894 (Central Act I of 1894), in relation to acquisition of land for the purpose for the Union in this State;

And, whereas, it has already been decided that the compensation shall be paid from the public revenues;

Now, therefore, in exercise of the powers conferred by Section 6 of the said Act, the Governor of Tamil Nadu hereby declares that the Land specified in the Schedule below and measuring 0.01.5 hectare of 50. Veesanam Village, Namakkal Taluk, Namakkal District, be the same a little more or less are

needed for public purpose, to wit, Road Over Bridge approach area due to the formation of Salem-Karur Broad Gauge Railway Line Project. A plan of the Land is kept in the Office of Special Tahsildar (Land Acquisition), Unit-I, Salem-Karur Broad Gauge Railway Line Project, Namakkal and may be inspected at any time during the office hours.
