Explanations.—(1) Dearness allowance.—In addition to the minimum rates of basic wages fixed above, the employees shall be paid dearness allowance as indicated below:—

- (i) The dearness allowance is linked to the Average Chennai City Consumer Price Index Number for the year 2000, that is 475 points (with base 1982=100) and for every rise of one point over and above 475 points, an increase of 19 paise (Nineteen paise) per day shall be paid as dearness allowance.
- (ii) The dearness allowance shall be calculated every year on the 1st April on the basis of the average of the indices for the preceding 12 months, that is from January to December.
- (iii) The first calculation shall thus be effective from the date of publication of the Notification in the *Tamil Nadu Government Gazette*, based on the Average Chennai City Consumer Price Index Number for the previous year.

(2) Where the nature of work is the same, no distinction in the payment of wages shall be made between men and women employees.

(3) To arrive at daily rates of wages, the monthly wages shall be divided by 26.

(4) To arrive at monthly wages, the daily minimum wages shall be multiplied by 30.

(5) Wherever the existing wages are higher than the minimum wages fixed herein, the same shall be continued to be paid.
