The field work of the Sixth Economic Census is to be conducted in any month between January 2012 to June 2012 as per the convenience of the State. During the field work, each and every household in the urban areas or in rural areas would be enumerated to capture the information on all Household enterprises/own account enterprises run by workers within fixed premises or without fixed premises, as well as other public and private establishments. This exercise is conducted in all the States and Union Territories across the country aims to provide a frame of all establishments engaged in various economic activity both in organized and unorganized sectors of the economy.

- 2. In the Fifth Economic Census, that was conducted during the year 2005, the State Level Co-ordination Committee was constituted under the Chairmanship of Chief Secretary, District Level Co-ordination Committee under the Chairmanship of District Collectors and the Co-ordination Committee for Corporation of Chennai under the Chairmanship of the Commissioner, Corporation of Chennai, Ministry of Statistics and Pogramme Implementation, Government of India in the letter second read above has stated that the above said arrangements under the overall control of Chief Secretary has worked very well in the past and therefore requested to order similar arrangements in the state for the period October 2011 to March 2014 for a period of 30 months which would be helpful in completing all the activities of the Sixth Economic Census in the State.
