Order:—Ms. No. 471, Home, 24th August 2011.

In the G.O. first read above orders have been issued to extend the Jurisdiction of Chennai City Police Commissionerate to the entire area of Chengai (East) Police District.

2. In the G.O. second read above orders have been issued for bifurcation of Chennai City Commissionerate and creation of New Commissionerate for the Chennai City Sub-urban Area with Head Quarters at St. Thomas Mount and named as "Chennai Sub-urban Commissionerate" in the G.O. third read above. Subsequently Notification regarding powers of Commissioner of Police, Chennai Sub-urban Commissionerate with Head Quarters at St. Thomas Mount-Magistrate Executive Magistrate including District Magistrate come into force have been issued in the G.O. fourth read above.

3. During review meeting conducted by the Hon'ble Chief Minister on 30-06-2011, it has been decided to merge the Chennai Sub-urban Police Commissionerate with Chennai City Police and form a Greater Chennai Police Commissionerate.

4. Based on the above decision, the Director General of Police has sent the proposal and informed to the Government that the original system of policing followed in 2005 with the Greater Chennai City Police functioning under the supervision of the Commissioner of Police, Chennai would be better suited in implementing same process, including methodology, technology and similar services to all the citizens of Chennai and adjoining areas and would ensure:—

- (i) Improved maintenance of Law & Order.
- (ii) Better System for Prevention and Detection of Crimes.
- (iii) Co-ordinated Traffic Management.
- (iv) Effective Man Management and
- (v) Fool proof VIP Security.

In view of the above, he has requested the Government to merge Chennai Sub-urban Police with Chennai Police and to form a Greater Chennai Police Commissionerate and to divide the Greater Chennai Police Commissionerate into four zones viz., North, South, East and West.

5. After careful examination, the Government have decided to accept the proposal of the Director General of Police for merger of Chennai Sub-urban Police with Chennai City Police to form Greater Chennai Police Commissionerate. Accordingly the Government accord sanction on the following:—

(i) Merger of Chennai Sub-urban Police with Chennai City Police and form a Greater Chennai Police Commissionerate.

(ii) Consequent on the merger, the Greater Chennai Police Commissionerate is divided into four Law and Order Zones having jurisdiction of 3 districts each as mentioned in the Annexure-I to this order. The New Organizational set up of Greater Chennai Police Commissionerate shall be as shown in the Annexure-II to this order.

(iii) Under Rule 4 (2) of the Indian Police Service (Cadre) Rules, 1954, the Government sanction four temporary posts of Joint Commissioners of Police viz., JCOP (CCB), JCOP Traffic (South), JCOP (West), JCOP (HQ) in the scale of pay of Rs. 37400-67000 + 8900 (GP) and four temporary posts of Stenographer in the scale of pay of Rs. 5200-20200 +

2400 (GP) with all admissible allowances under the orders and rules now in force from time to time for a period of one year from the date of appointment of the incumbents or the need therefore ceases whichever is earlier.

(iv) Revive the one post of Deputy Commissioner of Police (intelligence) which is kept abeyance and also redesignate the certain posts as mentioned in the Annexure - III to this order.

(v) Sanction a sum of Rs. 101.68 lakhs (Recurring Expenditure of Rs. 73.12 lakhs + Non-Recurring expenditure of Rs. 28.56 lakhs). The details of recurring and non-recurring expenditure are furnished in the Annexure - IV to this order.

6. The expenditure sanctioned in para 5 (v) above is debited in the Head of Account of "2055-00-Police".

7. The Chennai City Police (Extension to the Chennai City Sub-urban Area) Act, 2008 has to be repealed to achieve merger of Chennai Sub-urban Police with the Chennai City Police and to form a Greater Chennai Police Commissionerate. The Director General of Police is directed to send necessary proposal to repeal the relevant provision of the above said Act.

8. The Director General of Police is also directed to sent the proposals to Government for inclusion of expenditure such as Communication equipments, Arms & Ammunition under Modernisation of Police Force Scheme.

9. The expenditure is an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by sanction of an advance from the Contingency Fund, orders regarding which the Government in Finance (BG.I) Department will issue. The Director General of Police is directed to send necessary proposals to Government in Finance (BG.I) Department, in the prescribed format along with a copy of this order for sanction of an advance required for the current year from Contingency Fund.

10. He is also directed to send a draft explanatory note, indicating the total cost of the scheme, the cost that would be required for the implementation during the financial year etc., to Government in Finance (BG.I) Department for inclusion of the expenditure in the Supplementary Estimates for bringing it to the notice of the Legislature in due course.

11. This order issues with the concurrence of the Finance Department *vide* its U.O. No. 1900/FS(P)/Home.I/2011, dated 23-8-2011 and Finance (CMPC) 44123/2011, dated 23-8-2011 and Additional sanction Ledger No. 430 (Four hundred and thirty.)

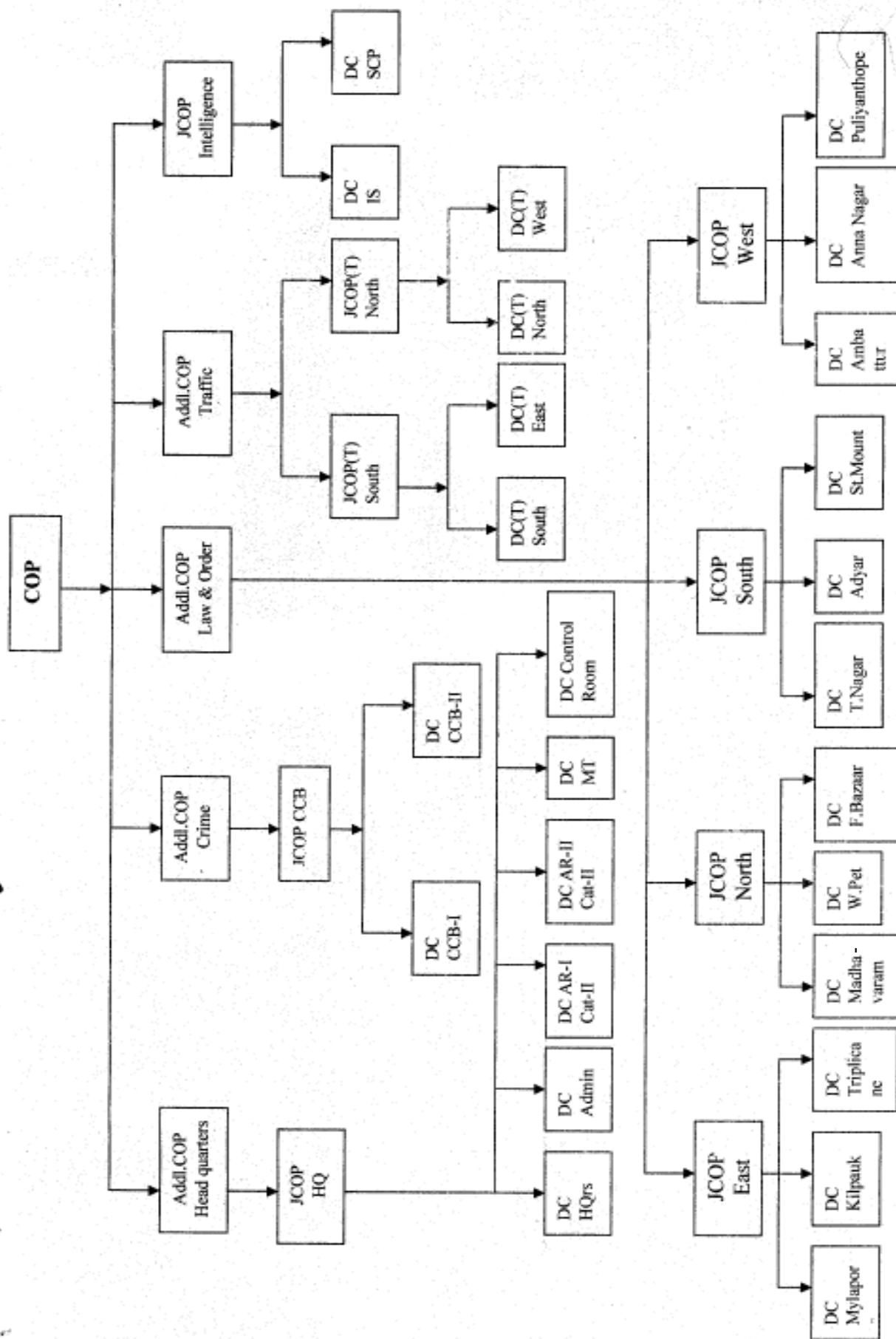

No. II(2)/PUSC/500/2011.—Whereas, an order has been made by the Government of Tamil Nadu in G.O.No. SR.I/271-10-2011, Public (SC) Department, dated 22nd September 2011, under Section 3(1)(i) of the Conservation of Foreign Exchange and Prevention of Smuggling Activities Act, 1974 (Central Act 52 of 1974), directing that Thiru Shaik Nasir Ahmed, son of Thiru Shaik, resident of No. 18/270, Mandy Syed Mia Street, Cuddapah, Andhra Pradesh, be detained;

And Whereas, the said Thiru Shaik Nasir Ahmed, son of Thiru Shaik, resident of No.18/270, Mandy Syed Mia Street, Cuddapah, Andhra Pradesh, cannot be found;

And Whereas, the Government of Tamil Nadu have reasons to believe that the said Thiru Shaik Nasir Ahmed, son of Thiru Shaik, resident of No.18/270, Mandy Syed Mia Street, Cuddapah, Andhra Pradesh in respect of whom the detention order has been made, has absconded and is concealing himself so that the said detention order cannot be executed.

Now therefore, in exercise of the powers conferred by Section 7 (1) (b) of the Conservation of Foreign Exchange and Prevention of Smuggling Activities Act, 1974 (Central Act 52 of 1974), the Government of Tamil Nadu hereby direct the said Thiru Shaik Nasir Ahmed, son of Thiru Shaik, resident of No. 18/270, Mandy Syed Mia Street, Cuddapah, Andhra Pradesh, to appear before the Superintendent of Police, Thiruvallur, at his office within a period of 15 days (fifteen days) from the date of publication of this order in the *Tamil Nadu Government Gazette*.
