**Exemption from operation of certain provision to Tamil Nadu State Marketing Corporation Limited, to pay the Special Privilege fee for the month of September 2010 under Tamil Nadu Liquor (Supply by Wholesale) Rules.**

**Order of detention of certain person and asking  
appearance before officials under conservation of  
Foreign Exchange and Prevention of Smuggling  
Activities Act.**

No. II(2)/PUSC/156/2011.—Whereas, an order had been made by the Government of Tamil Nadu in

G.O. No. SR.I/723-5/2010, Public (SC) Department, dated 30th December 2010 under Section 3(1)(i) of the Conservation of Foreign Exchange and Prevention of Smuggling Activities Act, 1974 (Central Act 52 of 1974), directing that Thiru Zahir Hussain, son of Thiru Sahul Hameed, resident of No. 9, Big Street, Triplicane, Chennai-5, be detained;

And Whereas, the said Thiru Zahir Hussain, son of Thiru Sahul Hameed, resident of No. 9, Big Street, Triplicane, Chennai-5, cannot be found;

And, Whereas, the Government of Tamil Nadu have reasons to believe that the said Thiru Zahir Hussain, son of Thiru Sahul Hameed, in respect of whom the detention order has been made, has absconded and is concealing himself so that the said detention order cannot be executed.

Now, Therefore, in exercise of the powers conferred by Section 7(1) (b) of the Conservation of Foreign Exchange and Prevention of Smuggling Activities Act, 1974 (Central Act 52 of 1974), the Government of Tamil Nadu hereby direct the said Thiru Zahir Hussain, son of Thiru Sahul Hameed, resident of No. 9, Big Street, Triplicane, Chennai-5, to appear before the Commissioner of Police, Egmore, Chennai-8, at his office within a period of 15 days (fifteen days) from the date of publication of this order in the *Tamil Nadu Government Gazette*.
