# Ad hoc Rules relating to the Temporary Post of Accounts Officer in the Department of Environment

[G.O. Ms. No. 229, Environment and Forests (EC.2), 27th December 2010.]

No. SRO B-2/2011.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:—

2. The rules hereby made shall be deemed to have come into force on the 3rd July 1997.

#### **RULES**

The General and the Special Rules applicable to the holders of the permanent post of Accounts Officer in category-1 of Class-III in the Tamil Nadu State Treasury and Accounts Service shall apply to the holders of the temporary post of Accounts Officer in the Department of Environment, subject to the modifications specified in the following rules:—

- 2. Constitution.—The post shall constitute a temporary addition to the said category in the said class of the said service.
- 3. Method of Appointment.—Appointment to the post shall be made by transfer from the post of Accounts Officer in Category-1 of Class-III of the said Service.
- 4. Pay.—There shall be paid to the holder of the post monthly pay calculaterd in the pre revised sale of pay of Rs. 8000-275-13500.

Provided that on and from 1st January 2006 the monthly pay shall be calculated in the scale of Rs. 15600-39100+Rs.5400 as Garde Pay (P.B.3).

Provided that the monthly pay shall be calculated in the scale of Rs. 15600-39100 + Rs. 5700 as Grade Pay (P.B.3) notionally with effect from 12th December 2007 and with monetary benefit from 1st August 2010.

# Ad hoc Rules relating to the Temporary Post of Ranger in the Department of Environment

[G.O. Ms. No. 230, Environment and Forests (EC.2), 27th December 2010.]

No. SRO B-3/2011.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:—

2. The Rules hereby made shall be deemed to have come into force on the 29th March 2005.

# **RULES**

The General and the Special Rules applicable to the holders of the permanent post of Ranger in category-1 of Class-I of the Tamil Nadu Forest Subordinate Service shall apply to the holders of the temporary post of Ranger in the Department of Environment, subject to the modifications specified in the following rules.

- 2. Constitution.—The post shall constitute a separate category in a distinct class of the said service.
- 3. Method of Appointment.—Appointment to the post shall be made by transfer from the post of Ranger in Category-1 of Class-I of the Tamil Nadu Forests Subordinate Service.
  - 4. Appointing Authority.—The appointing authority for the post shall be the Principal Chief Conservator of Forests.
- 5. Pay.—There shall be paid to the holder of the post a monthly pay calculated in the scale of pay of Rs. 6500-200-11000:

Provided that on and from 1st January 2006 the scale of pay is Rs. 9300-34800 + Rs. 4900 as a Grade Pay (Pay Band 2).

## PERSONNEL AND ADMINISTRATIVE REFORMS DEPARTMENT

#### Amendment to the Fundamental Rules

No. SRO B-4/2011.—In exercise of the powers conferred by the proviso to Article 309, read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendment to the Fundamental Rules:—

2. The amendment hereby made shall be deemed to have come into force on the 1st January, 2006.

### **A**MENDMENT

In the said Fundamental Rules, in rule 9, in sub-rule (21) (a), in clause (i) for the expression "the pay", the expression "the pay drawn in the prescribed pay band plus the applicable grade pay" shall be substituted.

No. SRO B-5/2011.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Social Welfare Department Notification S.R.O. No. 508/85, dated the 20th November 1985, published at pages 624-625 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 11th December 1985:—

### **AMENDMENTS**

In the said Rules, in rule 3,-

- (1) in sub-rule (a), for clause (ii), the following clauses shall be substituted, namely:-
- "(ii) By promotion from among the holders of the posts of Rural Welfare Officer (Women), Supervisor and Supervisor Garde-II by drawing a common panel; or
- (iii) By recruitment by transfer from among the holders of the post of Multi Purpose Health Worker (Female) in the Tamil Nadu Medical Subordinate Service under the Integrated Child Development Services Scheme.".
  - (2) for sub-rule (b), the following sub-rule shall be substituted, namely:-
- "(b) the ratio for appointment to the posts by direct recruitment and by promotion and recruitment by transfer (both combined) shall be 1:2:

Provided that the ratio for appointment to the posts by promotion and recruitment by transfer shall be 5:2:
