Amendments to Ad hoc Rules relating to Temporary Post of Translators under the Tamil Nadu General Subordinate Service.

[G.O. Ms. No. 375, Law (OP.III), 19th September 2011.]

No. SRO B-37/2011.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Amendments to the Ad hoc Rules issued in G.O.Ms. No. 40, Law Department, dated 8th March 1976 and published with the Law Department Notification No. SRO B-152/1976, published at pages 158 and 159 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 7th April 1976.

- 2. (1) The Amendment (1) hereby made shall be deemed to have come into force on the 1st September 1998.
 - (2) The Amendment (2) hereby made shall be deemed to have come into force on the 7th January 1987.
 - (3) The Amendment (3) hereby made shall be deemed to have come into force on the 9th October 1992.

AMENDMENTS

In the said Rules,-

- (1) In rule 1, for the expression, "Translators in the State Official Language (Legislative) Commission", the expression "Section Officers (Translation) in the Official Language (Legislative) Wing" shall be substituted.
 - (2) for rule 3, the following rule shall be substituted, namely:-
 - "3—Appointment—Appointment to the posts shall be made—
 - (i) by recruitment by transfer from any other service; or
 - (ii) by direct recruitment.",
 - (3) sub-rule (6) in rule 7 and rule 9 shall be omitted.

No. SRO B-38/2011.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Civil Services (Discipline and Appeal) Rules (in Volume I of the Tamil Nadu Services Manual, 1987):—

2. The amendments hereby made shall come into force on the 28th September of 2011.
