#### Amendment to the Tamil Nadu Chief Minister's Fire Service Medal Rules.

[G.O. Ms. No. 858, Home (S.C.), 14th December 2011.]

No. SRO A-23/2011.—The following amendment is issued to the Tamil Nadu Chief Minister's Fire Service Medal Rules, made in the G.O. Ms. No. 2148, Home (SC) Department, dated 21st September 1984 amended upto 2nd June 1997.

#### Amendment.

In the said Rules, - for Rule-10, the following rule shall be substituted:-

10. The Medal will carry a monthly allowance of Rs. 100/- per month for Fireman, Leading Fireman, Driver-Mechanic, Fireman-Mechanic, Fireman-Driver, Welder and equivalent ranks. The above allowance will be paid even if a recipient is promoted to a higher rank after the award of the medal and till his retirement.

2. The revised rule will be applicable from 1st August 2009.

3. This order issues with the concurrence of the Finance Department-vide its U.O. No. 52/DS(MDR)/Home-II/2011, dated 1st November 2011.

#### Draft Amendment to the Tamil Nadu Factories (Welfare Officers) Rules, 1953.

No. SRO A-24/2011.—The following draft of an amendment to the Tamil Nadu factories (Welfare Officers) Rules, 1953, which it is proposed to make in exercise of the powers conferred by Section 112 of the Factories Act, 1948 (Central Act LXIII of 1948), is hereby published for information of all persons likely to be affected thereby, as required by Section 115 of the said Act.

2. Notice is hereby given that the said draft amendment will be taken into consideration on or after the expiry of forty-five days from the date of publication of this Notification in the *Tamil Nadu Government Gazette*. Any objection or suggestion, which may be received from any person with respect thereto before the expiry of the above said period will be considered by the Government of Tamil Nadu.
