NOTIFICATIONS BY THE ELECTION COMMISSION OF INDIA.

ORDER OF ELECTION COMMISSION OF INDIA REGARDING USE OF ELECTOR'S PHOTO IDENTITY CARDS AND ALTERNATE PHOTO DOCUMENTS DURING GENERAL ELECTIONS TO TAMIL NADU LEGISLATIVE ASSEMBLY, 2011 SCHEDULED TO BE HELD ON 13-04-2011.

The following Order of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi - 110 001, dated: 23-03-2011 is republished:—

No.3/4/ID/2011/SDR(TN).—Whereas, Section 61 of the Representation of the People Act, 1951 provides that with a view to preventing impersonation of electors, so as to make the right of genuine electors to vote under Section 62 of that Act more effective, provisions may be made by rules under that Act for use of Electoral Photo Identity Cards for electors as the means of establishing their identity at the time of polling; and

2. Whereas, Rule 28 of the Registration of Electors Rules, 1960, empowers the Election Commission to direct, with a view to preventing impersonation of electors and facilitating their identification at the time of poll, the issue of Electoral Photo Identity Cards to electors bearing their photographs at State cost; and

3. Whereas, Rules 49H (3) and 49K (2) (b) of the Conduct of Elections Rules, 1961, stipulate that where the electors of a constituency have been supplied with Electoral Photo Identity Cards under the said provisions of Rule 28 of the Registration of Electors Rules, 1960, the electors shall produce their Electoral Photo Identity Cards at the polling station and failure or refusal on their part to produce those Electoral Photo Identity Cards may result in the denial of permission to vote; and

4. Whereas, a combined and harmonious reading of the aforesaid provisions of the said Act and the Rules, makes it clear that although the right to vote arises by the existence of the name in the electoral roll, it is also dependent upon the use of the Electoral Photo Identity Card, where provided by the Election Commission at State cost, and that both are to be used together; and

5. Whereas, the Election Commission made an Order on the 28th August 1993, directing the issue of Electoral Photo Identity Cards (EPICs) to all electors, according to a time bound programme; and

6. Whereas, the Commission has taken note of the fact that over the last few years since the implementation of the programme of issue of EPICs was taken up, the election machinery of Tamil Nadu have issued these cards to a substantially high number of electors and made all possible efforts, by way of repeated rounds of the constituencies and areas, with a view to issuing cards to the left-out electors; and

7. Whereas, electoral rolls containing photographs of the electors have been prepared and published in Tamil Nadu; and

8. Whereas, at the general election to the Legislative Assembly of Haryana held in January - March 2000, and at all general and bye-elections held since then, the Commission had directed that all electors who were issued with EPICs should produce those cards to exercise their franchise at the said elections, and that it would permit the odd electors who have not obtained their EPICs to vote at the said elections, provided their identity is otherwise established by production of one of the alternative documents prescribed by the Commission; and

9. Whereas, voters' slip with the photograph of electors have been issued to the electors in Tamil Nadu.

10. Now, therefore, after taking into account all relevant factors and the legal and factual position, the Election Commission hereby directs that all electors in each of the 234 Assembly Constituencies, in Tamil Nadu, for the general election notified on 19th March 2011, shall produce their EPICs for establishing their identity before casting their votes. Electors who do not have EPIC shall have to produce authenticated Photo Voter Slip issued by Election Machinery. Voters who have not have photograph in Photo electoral roll shall have to produce any of the following alternative photo documents for establishing their identity.

- (i) Passports,
- (ii) Driving License issued up to 28-02-2011,
- (iii) Income Tax Identity (PAN) Cards,
- (iv) Service Identity Cards issued to its employees by State/Central Government, Public Sector Undertakings, Local Bodies or Public Limited Companies with photographs,
- (v) Passbooks with photograph issued by Public Sector Banks/Post Office and Kisan Passbooks (Accounts opened on or before 28-02-2011),
- (vi) Pension Documents with photograph, such as ex-servicemen's Pension Book/Pension Payment Order, ex-servicemen's Widow/Dependent Certificates issued up to 28-02-2011,
- (vii) Freedom Fighter Identity Card, with photo,
- (viii) Property Documents such as Pattas, Registered Deeds, etc. with photograph,
- (ix) SC/ST/OBC Certificates issued by competent authority with photograph (issued upto 28-2-2011),
- (x) Arms Licenses with photograph,
- (xi) Certificate of Physical Handicap with photograph issued by the competent authority issued upto 28-2-2011,
- (xii) Job Cards issued under NREGA with photograph issued upto 28-2-2011,
- (xiii) Health Insurance Scheme Smart Cards with photograph (Ministry of Labour's Scheme).

11. Any of the above mentioned documents that is available only to a member of family may be used for identifying the other members of the family provided all members come together and are identified by such member.

12. Notwithstanding anything in Para 10 above, Overseas electors who are registered in the electoral rolls under Section 20A of the Representation of the People Act, 1950 based on the particulars in their passport, shall be identified on the basis of their original passport only (no other identity document) in the polling station.
