TAMIL NADU STATE ELECTION COMMISSION, CHENNAI-600 106.

[ELECTIONS— URBAN LOCAL BODIES—MAY 2011—CASUAL INDIRECT ELECTIONS TO FILL UP THE VACANCIES IN THE OFFICES OF CHAIRMAN, VICE-CHAIRMAN OF VIKKIRAVANDI TOWN PANCHAYAT—VILLUPURAM DISTRICT—POSTPONED—NOTIFIED.]

In exercise of the powers conferred under Section 27 and sub-section (1) of Section 43-B of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920) and sub-rule (4) of rule 99 of the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporations (Elections) Rules, 2006, the Tamil Nadu State Election Commission *inter alia* notified the election to the Offices of the Chairman, Vice-Chairman of Vikkiravandi Town Panchayat of Villupuram District to be held on 31-5-2011 as per the S.O. No. 8/2011/ME2, dated 19th May 2011.

Whereas in the reference Rc. No. PC3/Pdl.17/2011, dated 18th May 2011, the District Collector, Villupuram District has reported that the situation in the said local body area is very sensitive and not conducive to hold the Indirect Elections due to the murder of Chairman and Vice-Chairman of the said Town Panchayat and communal problem. Further, recommended to postpone the said election for the Offices of Chairman and Vice-Chairman of Vikkiravandi Town Panchayat.

In view of the report sent by the District Election Officer/District Collector, Villupuram District and in exercise of the powers conferred under rule 115 of the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporations (Elections) Rules, 2006, the Tamil Nadu State Election Commission hereby orders for the postponement of the election to the Offices of Chairman and Vice-Chairman of Vikkiravandi Town Panchayat notified in the S.O. No. 8/2011/ME2, dated 19th May 2011. Accordingly, the following amendments are issued to the said S.Os.

AMENDMENT

In the said order, in the Annexure, under the Heading "TOWN PANCHAYAT" in SI.No. 6 and 7, the District Villupuram and the corresponding entries relating thereto shall be omitted.
