In exercise of the powers conferred by sub-section (2) of Section 30 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994) read with rule 7 of the Tamil Nadu Panchayats (Elections) Rules, 1995, the Tamil Nadu State Election Commission hereby designates the Block Development Officers (Block Panchayat) to be the Panchayat Electoral Registration Officers for the purposes of preparing and publishing Panchayat Electoral Rolls in respect of Wards of Panchayats lying within their respective jurisdiction in connection with the conduct of ordinary elections, 2011 to Panchayats and subsequent casual elections in the State.
