Ms.No.136, Municipal Administration and Water Supply (Election), Department, Dated 11th June 1996, G.O.Ms.No.85, Municipal Administration and Water Supply (Election) Department, dated 18th June 2001 and in accordance with the G.O.Ms.No.75, Municipal Administration and Water Supply (Election) Department, Dated 1st August 2006 issued in *Tamil Nadu Government Gazette* (No.221), dated 1st August 2006 and also in accordance with G.O.Ms.No.124, Municipal Administration and Water Supply (Election) Department, dated 7th September 2011 issued in *Tamil Nadu Government Gazette* (No.311), dated 7th September 2011, the Commissioner, Corporation of Chennai, hereby effects reservation of 58 Wards to Women (General) based on Census Population 2001 and continue to reserve 26 seats to Scheduled Caste as per the last preceding census, for the purpose of elections to be held for the Corporation Council, notifies as follows:-
