The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below have to be acquired for industrial purpose, to wit, for setting up of Industrial Complex by SIPCOT Sriperumbudur Expansion Scheme and Complex it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled or managed by Government, the following Notice is issued under sub-section (1) of Section 3 of the Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997 (Tamil Nadu Act 10 of 1999).
