- S.O. 2227 (E).—In exercise of the powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955), the Central Government hereby makes the following Order further to amend the Removal of (Licensing Requirements, Stock Limits and Movement Restrictions) on Specified Foodstuffs Order, 2002, namely:-
- 1. (1) This order may be called the Removal of (Licensing Requirements, Stock Limits and Movement Restrictions) on Specified Foodstuffs (Amendment) Order, 2011.
 - (2) It shall come into force on the 1st day of October 2011.
- 2. In the Removal of (Licensing Requirements, Stock Limits and Movement Restrictions) on Specified Foodstuffs Order, 2002, in clause 7,—

- 1. (1) This order may be called the Removal of (Licensing Requirements, Stock Limits and Movement Restrictions) on specified Foodstuffs (Fourth Amendment) October, 2011.
