ORDER: No. 174, Public (Miscellaneous), 21st February 2013

In the Government Order read above, the list of Public Holidays under Negotiable Instruments Act 1881, for the year 2013 has been notified. Among others, 30.09.2013 was declared as Public Holiday under the Negotiable Instruments Act, for Half Yearly Closing of Accounts for Commercial Banks and Co-operative Banks. The Government of India, Ministry of Finance, Department of Financial Services in their letter read above have requested all the State Governments/Union Territories, not to notify 30th September as a Bank Holiday under Section 25 of Negotiable Instruments Act 1881.

2. Accordingly, the Government direct that the holiday for Half Yearly closing of accounts for Commercial Banks and Cooperative Banks on 30.09.2013 notified in the G.O. read above under Section 25 of Negotiable Instruments Act 1881, be cancelled and the day on 30.09.2013 is declared as working day for all Commercial Banks and Co-operative Banks.
