**Exemption from the Provisions of Development Regulations of Second Master Plan for Chennai Metropolitan Area relating to the Construction of Commercial Building at T. Nagar, Chennai under the Tamil Nadu Town and Country Planning Act.**

No.II(2)/HOU/238/2013.—In exercise of the powers conferred by Section 113 of Tamil Nadu Town and Country Planning Act (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby exempts construction of Basement Floor + Stilt (Part) / Ground Floor (Part) + First Floor + Mezzanine Floor + Second Floor + Mezzanine Floor + Third Floor of Commercial Building at Old Door No.156, New Door No. 20, North Usman Road, T.Nagar, Chennai-600 017, In T.S.No.5237, Block No. 119 of T. Nagar, Village Chennai, by relaxing the Regulation 26(4) E and 26(4) D relating to Side Set Back (North) and (South) and Floor Space Index of Development Regulations of Second Master Plan for Chennai Metropolitan Development Authority Area 2026, Subject to collection of penal fee equivalent to

(a) 1.25 x guideline value of equivalent land for violated area for set back spaces violation amounting to floor Space Index violation and

(b) 2.00 x guideline value equivalent land for the violated floor area for FSI violation for regularization of set back violation and FSI violation by the Chennai Metropolitan Development Authority, and also subject to the condition that, NOC shall be obtained from the Director of Fire and Rescue Services prior to issue of completion certificate.
