No. I/PUSP/37/2014.—The following Notification of the Election Commission of India, New Delhi, dated 6th October 2014 is republished:—

In exercise of the powers conferred by sub-section (1) of Section 13A of the Representation of the People Act, 1950 (43 of 1950), the Election Commission of India, in consultation with the Government of Tamil Nadu, hereby nominates Dr. Sandeep Saxena, IAS (1989) as the Chief Electoral Officer for the State of Tamil Nadu with effect from the date he takes over charge and until further orders.

2. Dr. Sandeep Saxena, IAS shall cease to hold and hand over forthwith the charge of all or any charges of work under the Government of Tamil Nadu, which he may be holding before such assumption of office.

3. Dr. Sandeep Saxena, IAS while functioning as the Chief Electoral Officer, Tamil Nadu shall not hold any additional charge whatsoever under the Government of Tamil Nadu except that he should be designated Secretary to the Government in charge of Election Department in the State Secretariat.
