Award of the Police Medal for Gallantry on the occasion of the Republic Day, 2014.

No.36-Pres/2014.—The President is pleased to award the Police Medal for Gallantry to the under mentioned officer of Tamil Nadu Police:-

Name & Rank of the Officer

Shri T. Alwin Sudhan (Posthumously) Sub-Inspector

Statement of service for which the decoration has been awarded

Shri T. Alwin Sudhan was recruited as direct Sub- Inspector of Police (Category-I) during the year 2011. After completion of academic training he was posted to Tirunelveli District, Sankarankovil Taluk, PS for practical training. After completion of Practical training, he was posted in Sivagangai District and joined in Thirupachethy PS on 24-8-2012. During the short period of two months, he has done an excellent job in Law and Order. He has taken severe action against the sand mafia gangs and curtailed illegal activities. He has registered 28 cases under various sections of IPC and controlled the activities of rowdism. Out of 28 cases, 7 cases were convicted, 8 cases were charge sheeted and 7 cases are UI and 6 cases were action dropped. He had performed various bandobust duties in temple functions conducted in Micheal Pattinam, Meenatchipuram, Mathur, T. Velarngulam, Vempathur and Malavarayanenthal Villages which are in limits of Thiruppachity PS. on 11.9.2012 during the Immanuel Shekaran Memorial Day, he has done a good job to public and the volunteers in the sensitive area of Pacheri Colony areas. on 27-10-2012 during the Maruthupandiyar Guru Pooja at kalaiyarkovil he has performed well and ensured for free flow of traffic movements in NH.49. At that time he got informed that some rowdies, under the head of Prabu, who belongs to V Puthukulam in a 2-TATA Sumo Car were making rowdism and causing public nuisance at Vempathur. To solve the problem he went to the spot. At that time above said Prabu gang quarreled with Manamadurai Deputy Superintendent of Police Shri Karunanithi and Inspector Shri Vijayakumar at Vempathur Lashmipuram road and knocked down the Deputy Superintendent of Police and tried to kill him by sword. At that time Shri T. Alwin Sudhan, Sub Inspector of Police, tried to save him and also try to secure the rowdy. But the rowdy Prabu attacked the Sub Inspector of Police with sword on his chest. On the way to hospital he succumbed to injury.

Shri T. Alwin Sudhan saved the life of the Deputy Superintendent of Police and one Inspector and 2 Head Constable by giving his soul.

In this encounter Late Shri T. Alwin Sudhan, Sub Inspector displayed conspicuous gallantry, courage and devotion to duty of a high order.

This award is made for gallantry under rule 4(i) of the Rules governing the award of Police Medal and consequently carries with it the special allowance admissible under Rule 5, with effect from 27-10-2012.
