## LABOUR AND EMPLOYMENT DEPARTMENT

**Draft Amendments to the Tamil Nadu Trade Unions Regulations under the Trade Unions Act.**

[G.O.Ms. No.36, Labour and Employment (K2),  
 30th April 2014, Chithirai 17, Jaya,  
 Thiruvalluvar Aandu 2045.]

No.II(2)/LE/340/2014.—The following draft amendments to the Tamil Nadu Trade Unions Regulations, 1927 which they are proposed to make in exercise of the powers conferred by Section 29 of the Trade Unions Act, 1926 (Central Act XVI of 1926), are hereby published for general information as required by Section 30 of the said Act.

2. Notice is hereby given that the draft amendments will be taken into consideration on or after the date of expiry of three months from the date of publication of this Notification

in the *Tamil Nadu Government Gazette* and that any objection or suggestion which may be received from any person with respect thereto, before the expiry of the period aforesaid will be considered by the Government of Tamil Nadu. The Objections and suggestions, if any, should be addressed to the Secretary to Government Labour and Employment Department, Fort St.George, Secretariat, Chennai-600 009 through the Commissioner of Labour, Chennai-600 006.

## DRAFT AMENDMENTS

In the said Regulations,—

(1) in clause 14, for the expression "Rs. 100/- (Rupees one hundred only)", the expression "Rs. 1000/- (Rupees one thousand only)" shall be substituted;

(2) in clause 15, in sub-clause (2), for the expression "Rs.25/-(Rupees twenty five only)", the expression "Rs. 250/- (Rupees two hundred and fifty only)" shall be substituted.

**Specifications of supply of Protective Clothing Materials to the every employer of Labour on Plantations at free of cost under the Plantations Labour Act.**

No.II(2)/LE/341/2014.—Under rule 68 of the Tamil Nadu Plantations Labour Rules, 1955 and its supersession of Labour and Employment Department Notification No. II(2)/LE/3120/80, dated the 30th April 1980, Published on pages 491 and 492 of Part II-Section 2 of the *Tamil Nadu Government Gazette*, dated the 16th July 1980, the Governor of Tamil Nadu hereby notifies that every employer of labour on plantations shall supply free of cost to every worker employed on the plantations, the materials specified in the Table below for the protection from rain or cold:—

2. The bed-sheets shall not be less than 90 inches in length and 54 inches in breadth either mill made or handloom. The field cumbly shall not be less than 2.74 metres in length and 1.22 metres in breadth and the rug shall not be less than 2.13 metres in length and 1.22 metres in breadth and weighing 1.8 Kilograms. They shall be of such suitable quality, as may be approved by the Chief Inspector of Plantations:

Provided that in case of non-availability or difficulty in procurement of field cumblies with specification mentioned above, the employer shall supply an alternative cumbly, commonly referred to as "Calamity Materials", which shall be not less than 220 centimetres in length, 125 centimetres in breadth and weighing not less than 1500 grams, having a composition of 50% wool and 50% Acrylic/Polyester/Cotton blend:

Provided further that the variation in the dimension of the cumblies, rugs and bed-sheets of good quality upto 5 per cent may be allowed by the Chief Inspector of Plantations:

Provided also that both the employer and the union/unions representing majority of workmen agree on a particular quality of rug, the Chief Inspector of Plantations may, after recording the reasons therefor, accord approval for the same without insisting on the weight of such rug.

3. All temporary workmen, who have put in a service of three months prior to 31st May and the 31st October of each year shall be supplied with a field cumbly and a rug as specified above, if they continue to be in employment on or after the 1st June and the 1st November of that year, as the case may be.

4. Supervisors and Assistant Supervisors are eligible for rug or rain coat at a cost equivalent to the value of 2 cumblies provided for employees, subject to the conditions that one category of such employees are eligible for only one type of article and that any excess cost involved, would be recoverable from the employees.

*Explanation.*—In this Notification, "Member of the Staff" means "a person employed to do clerical work".
