The following errata is issued to the Higher Education Notification No. SRO B-44/2009, published at pages 80-103 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 22nd July 2009:—

In the said Notification,—

- (i) in page 86, in rule 4, for "by recruitment", read "by direct recruitment";
- (ii) in page 99, in the Annexure, in class IV, in column (4) against Category 3 "Physical Training Instructor" in column (2) thereof, after item (i), the following item shall be added, namely:—
- "( $\it ii$ ) State Government Teachers' Certificate in Physical Education awarded to Ex-Servicemen (Higher Grade)".

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Technical Educational Subordinate Service (Section 45, in Volume III of the Tamil Nadu Services Manual, 1970).

2. The amendments hereby made shall be deemed to have come into force on the 6th July 2009.

#### **AMENDMENTS**

In the said Special Rules,-

in rule 2, in sub rule (a), against Class III, in column (1), for the entries "1. Instructor (Technical)" in column (2) and the corresponding entries in column (3) thereof, the following entries shall be substituted, namely:-

"1. Instructor (Technical)

(i) Instructor in Printing Technology (i) Promotion; or

(ii) Direct recruitment; or

(iii) Recruitment by transfer from any other service.

(ii) Instructor in TextileTechnology (i) Direct recruitment; or

(ii) Recruitment by transfer from any other service.

(iii) Instructor in (i) Direct recruitment; or

Leather Processing (ii) Recruitment by transfer from any other service.".

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Technical Educational Subordinate Service (Section 45, in Volume III of the Tamil Nadu Services Manual, 1970).

2. The amendments hereby made shall come into force on the date of publication of these rules.

#### AMENDMENTS

In the said Special Rules,—

- (2) in rule 2, in sub-rule (a),-
- (a) against Class-II in column (1), categories 1 and 2 in column (2) and the corresponding entries in column (3) thereof, shall be omitted;
- (b) against Class-III in column (1), category 1 in column (2) and the corresponding entries in column (3) thereof, shall be omitted;
  - (3) in rule 3, for items (ii) and (iii), the following items shall respectively, be substituted, namely:-
    - "(ii) Categories 3 to 6 in Class II" and
    - "(iii) Category 2 in Class III";
  - (4) in the Annexure,-
- (a) for the heading "(Referred to in Rule 9)", the heading "(Referred to in rule 6 (b))" shall be substituted;
- (b) against Class-II in column (1), categories (1) and (2) in column (2) and the corresponding entries in columns (3) and (4) thereof, shall be omitted;
- (c) against Class-III in column (1), category (1) in column (2) and the corresponding entries in columns (3) and (4) thereof, shall be omitted.
