No. SRO B-29/2014.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Forest Subordinate Services (Section 12 of Part—III-B of the Tamil Nadu Service Manual 1970).

2. The amendments hereby made shall be deemed to have come into force on the 5th October 1998.

(b) after the entries "Forest Watchers and Mali", in Column (1), and the corresponding entries in column (2), thereof, the following entries shall respectively be inserted, namely:—

"Forest Watcher Grade-II	From the post of field man Grade-II in the
	Cinchona Department",.

(3) in rule 3, in the Tabular Column under CLASS-I, for the expression "4. Forest Watcher" in the first column against the entry "Officers incharge of the Division concerned *i.e.*, Divisional Forest Officer /Working Plan Officer / Wildlife Warden / Forest Utilization Officer, as the case may be "in the second column thereof, the expression "4. Forest Watcher and 4-a Forest Watcher Grade-II shall be substituted;

(4) in the Table, under rule 5, for the entry "(ii) Promotion of Forest Watcher" in column -2, against the category "Forest Guard" in column 1 thereof, the following entry shall be substituted namely:—

(ii) "Promotion of Forest Watcher or Forest Watcher Grade-II";

(5) in rule 13, for the expression "Forest Watchers", the expression, "Forest Watchers, Forest Watchers Grade-II shall be substituted.
