Amendments to the Tamil Nadu Liquor (Licence and Permit) Rules

[G.O.Ms. No. 1, Home, Prohibition and Excise (VIII), 2nd January 2014.]

No. SRO A-7/2014.— In exercise of the powers conferred by Sections 17-C, 17-D, 17-E, 18-B, 18-C, 20 and 21 read with Section 54 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Liquor (Licence and Permit) Rules, 1981:—

2. The amendments hereby made shall come into force with effect on and from the 1st April 2014.

AMENDMENTS

In the said Rules, in rule 17, in sub-rule (b),-

- (i) in clause II,-
- (a) for the expression "a licence fee of Rs. 5,000/- (Rupees five thousand only)", the expression "a licence fee of Rs. 10,000/- (Rupees ten thousand only) shall be substituted;
- (b) for the expression "an application fee of Rs. 1,000/- (Rupees one thousand only)", the expression "an application fee of Rs.3,000/- (Rupees three thousand only)" shall be substituted;
