#### Amendments to the Tamil Nadu Prison Rules

[G.O. Ms. No. 733, Home (Prison.I), 26th September 2014.]

No. SRO A-26/2014.—In exercise of the powers conferred by Section 59 of the Prisons Act, 1894 (Central Act IX of 1894) the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Prison Rules, 1983.

#### AMENDMENTS

In the said Rules, in rule 18, in sub-rule (1) for the Table, the following Table shall be substituted, namely:—

#### Draft Amendments to the Tamil Nadu Plantations Labour Rules.

[G.O. Ms. No. 112, Labour and Employment (K2), 25th September 2014, Purattasi 9, Jaya, Thiruvalluvar Aandu-2045.]

No. SRO A-27/2014.—The following draft amendments to the Tamil Nadu Plantations Labour Rules, 1955 which it is proposed to make in exercise of the powers conferred by sub-sections (1) and (2) of Section 43 of the Plantations Labour Act, 1951 (Central Act LXIX of 1951), is hereby published for information of all persons likely to be affected there by as required by the said sub-section (1) of Section 43 of the said Act.

2. Notice is hereby given that the said draft amendments, will be taken into consideration on or after the expiry of a period of six weeks from the date of publication in the *Tamil Nadu Government Gazette*. Any objection or suggestion which may be received from any person with respect thereto before the aforesaid period will be considered by the Government of Tamil Nadu. Objection or suggestion, if any, should be addressed to the Secretary to Government, Labour and Employment Department, Chennai-600 009 through the Commissioner of Labour, Chennai-600 006 in duplicate.

## DRAFT AMENDMENTS

In the said Rules,—

(1) in rule 5, in sub-rule 4, for the expression "the adolescents and children employed," the expression " the adolescents employed" shall be substituted; and

(2) in rule 27, for the expression "the latter", the expression "State Government upon request by the Chief Inspector" shall be substituted.
