(2) The rules hereby made shall be deemed to have come into force on the 14th June 2013.

Rules

The General and Special Rules applicable to the holders of the permanent post of Clinical Associate Professor in Category 9 of Class I in Branch-I Medical of the Tamil Nadu Medical Service shall apply to the holders of the temporary Post of Clinical Associate Professor of Cosmetology, subject to the modifications specified in the following rules:-

- 2. **Constitution:** The Post shall constitute a district category in the said class of the said branch of the said service.
 - 3. Appointment:- Appointment to the post shall be made as follows:-

- (iii) must have served in the cadre of Assistant Professor in Dermatology for a period of not less than five years in a recognised medical college.
- 5. *Pay:* There shall be paid to the holder of the post a monthly pay calculated in the Pay Band-III of Rs. 15600-39100 with Grade pay of Rs. 7,600/-

Rules

The General and the Special Rules applicable to the holders of the permanent post in Class LVIII of the Tamil Nadu General Service shall apply to the holders of the temporary post of Assistant Director (Administration) in the Town Country Planning Department, subject to the modifications specified in the following rules:—

- 2. Constitution:- The post shall constitute a separate category in a distinct class of the said service.
- 3. **Appointment:-** Appointment to the post shall be made by recruitment by transfer from among the holders of the post of Superintendent in the Tamil Nadu Ministerial Service in the Town and Country Planning Department.
 - 4. Appointing authority:- The appointing authority for the post shall be the Government.
