Applications in Urgent Criminal Matters should be made to the High Court of Judicature, Madras, if no Vacation Sessions Judge is appointed or in the absence of the Vacation Sessions Judge for Salem District during the above adjournments.

Under Section 38 of the Tamil Nadu Civil Courts Act, as amended by Section 4 of the Tamil Nadu Act 17 of 1958 if a Vacation Civil Judge is appointed to Salem District, suits, appeals and other proceedings of the urgent nature will be received and disposed of by him in terms and rules that may be.
