In exercise of the powers conferred by clause (a) of sub-section (1) read with sub section (2) of section 2 of the Indian Tolls Act, 1851 (Central Act VIII of 1851), as amended by the Tamil Nadu Tolls and Motor Vehicles Taxation (Amendment) Act, 1938 (Tamil Nadu Act VI of 1938) and the Indian Tolls Tamil Nadu Amendment Act, 1942 (Tamil Nadu Act XIV of 1942), the Governor of Tamil Nadu hereby levies the tolls for the financial year 2015-2016 on the classes of Motor Vehicles specified in column (2) of the table below, which enter into or transit through Mamallapuram Town Panchayat at the rates specified in column (3) thereof, namely:—
