The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below have to be acquired for Industrial Purposes, to wit, for Second Mine Expansion Scheme of Neyveli Lignite Corporation Limited and it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled or managed by Neyveli Lignite Corporation Limited. The following notice is issued under sub-section (1) of Section 3 of the Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997.
