APPOINTMENT OF DATES FOR VARIOUS STAGES OF BYE-ELECTION TO TAMIL NADU LEGISLATIVE ASSEMBLY FROM 139. SRIRANGAM ASSEMBLY CONSTITUENCY AND FIXATION OF HOURS OF POLL TO FILL A VACANCY CAUSED BY THE DISQUALIFICATION OF A MEMBER

The following Notification of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110 001, dated 19th January, 2015 [29 Pausha, 1936 (Saka)] is published:-

No. 100/TN-LA/1/2015:—Whereas, the seat of Ms. J Jayalalithaa in the Legislative Assembly of the Tamil Nadu State, elected from 139-Srirangam Assembly Constituency, has become vacant on 27th September, 2014, by reason of her disqualification under Section 8 of the Representation of the People Act, 1951 read with Article 191(1) (e) of the Constitution of India; and

- 2. Whereas, a bye-election is to be held for the purpose of filling the vacancy so caused; and
- 3. Now, therefore, in pursuance of sub-section (1) of Section 150, and Sections 30 and 56 of the representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-
- (A) Calls upon the said 139-Srirangam Assembly Constituency in the State of Tamil Nadu to elect, bebore the 18-02-2015 (Wednesday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for the purpose of filling the said vacancy in the Legislative Assembly of the State; and
 - (B) Appoints, with respect to the said election,-
 - (a) the 27-01-2015 (Tuesday), as the last date for making nominations;
 - (b) the 28-01-2015 (Wednesday), as the date for scrutiny of nominations;
 - (c) the 30-01-2015 (Friday), as the last date for withdrawal of candidatures;
 - (d) the 13-02-2015 (Friday), as the date, on which a poll shall, if necessary, be taken;
 - (e) the 18-02-2015 (Wednesday), as the date before which the election shall be completed, and

(C) Fixes the hours from 7.00 A.M. to 6.00 P.M. as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
