The following Notification of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110 001, Dated 18th March, 2015 [27 Phalguna (Saka) 1936] is published:

No 429/TN/2015(3).- In exercise of the powers conferred by sub-section (1) of Section 13 (C) of the Representation of the People Act, 1950 (43 of 1950), the Election Commission of India hereby makes the following amendment in the Notification No. 429/TN/2008(3) dated 18-06-2008, as amended from time to time, relating to the change of the nomenclature of Assistant Electoral Registration Officers, for Assembly Constituency in the State of Tamil Nadu.
